## Good Hope City Council Minutes March 7, 2016

- 1. Mayor Guthrie called the meeting to order, Councilman Dean Freese led the invocation and Councilman William Malcom led the pledge.
- 2. Roll Call was performed by City Clerk Renette Yancey Councilman David Mullis was absent. All others were present.
- 3. Approval of Agenda: Councilman Eddie Sheppard made the motion to accept the Agenda and Councilman William Malcom seconded. Motion passed.
- 4. Approval of last meetings minutes: Councilman Dean Freese made the motion to accept the Minutes and Councilman Josh Jameson seconded. Motion passed.
- 5. Public Forum: The was no Public Forum
- 6. Committee Reports and updates:
  - A. LDO and Ordinances of the City, Mayor Guthrie and Councilman David Mullis have been proof reading the City Ordinances and have noted missing sections and typing errors. Mayor Guthrie divided the proof reading of the LDO among the himself and the Council. The goal is to have all the corrections sent to Justin this month.

- 9. Council Discussion Items: Councilman Joshua Jameson brought to the attention of the council that several citizens in the community have complained about the lack of upkeep to the property belonging to the owner of Good Hope Outdoor Products on Highway 83. Several other members of the Council said they have received the same complaints. After some discussion Mayor Guthrie agreed to send a letter stating that the property needs to be cleaned up.
