Good Hope City Council Minutes June 6, 2016

- 1. Mayor Guthrie called the meeting to order, Councilman Dean Freese led the invocation and Councilman Eddie Sheppard led the pledge.
- 2. Roll Call was performed by Mayor Guthrie.

- 3. Approval of Agenda: Councilman Mullis made the motion to accept the Agenda and Councilman Sheppard seconded. Motion passed.
- 4. Approval of last meetings minutes: Councilman Malcom made the motion to accept the Minutes and Councilman Mullis seconded. Motion passed.
