Good Hope City Council Minutes April 2, 2018

Jason Laughinghouse was sworn as City Councilman by Judge Burke in a ceremony before tonight's meeting.

- **1.Call to Order**: Mayor Guthrie called the meeting to order. Councilman William Malcom led the invocation. Councilman Jason Laughinghouse led the pledge.
- 2. Roll Call was performed by Mayor Guthrie. Clerk Renette Yancey was absent, all others were present.
- **3**. **Approval of Agenda**: Councilman David Mullis made a motion to accept the agenda, Councilman Keith Prather seconded and the motion passed.

- C. Project Update The revised proposal for the 2016/2017 LMIG project was received from Todd Parker at a cost of \$29,555.00 this will be paid out of SPLOST 7 funds and LMIG Grants. The permits should be issued within the next 2 weeks with construction beginning in May.

- A. **Recertification as a City of Ethics** The City is due to be recertified as a City of Ethics, Mayor Guthrie presented the required Resolution to the Council.
