## Good Hope City Council Minutes July 10, 2023

1. **Call to order:** Mayor Randy Garrett called the meeting to order at 6:30 pm, and led the invocation, Councilmember David Mullis led the pledge.
2. **Roll Call:** Performed by City Clerk Missy Daigle, Councilmembers William Malcom, David Mullis, Jr., Kelsey Malcom, and Keith Prather were in attendance, Councilmember John Robison, Jr. was absent.
3. **Approval of agenda:** There were no amendments to be added, Councilmember William Malcom made a motion to accept the agenda, Councilmember David Mullis, Jr. seconded and all approved.
4. **Approval of previous meeting's minutes:** Councilmember Keith Prather made a motion to accept June Council minutes and Councilmember David Mullis, Jr. seconded, all approved, motion passed and minutes were recorded.
5. **Public Forum:** There were no visitors present.
6. **Committee Reports/Updates:**
  - A. **Budget Update:** The council was presented with a year-to-date report. Councilmember Keith Prather made a motion to accept the budget report and Councilmember William Malcom seconded the motion. All were in favor and the budget report was approved.
  - B. **City Hall rentals:** The City is continuing to do well with rentals, every weekend in July is booked.
  - C. **Display Case for Memorabilia:** Councilmember William Malcom is still waiting to receive a quote; he was told that there is a delay due to a wait on an additional quote for the glass. Councilmember Keith Prather reached out to Jeff Witcher and he will be available to come look at the space for the cabinet on July 11th or 12th.
7. **Unfinished business:** There was no unfinished business.
8. **New Business:**
  - A. **Storm Water Management Agreement Document:** Mayor Garrett proposed to the council the adoption of a Storm Water Management Agreement, after much discussion it was decided that the agreement would be presented to the City Attorney and have him write a draft for the City of Good Hope.
  - B. **Public meeting/Council update from GTA:** Mayor Garrett let the council know that the new date for the GTA presenting information will be July 20, 2023 at 6:30 PM.
9. **Council Discussion Items for the good of the order:** Mayor Garrett proposed that we begin looking into salary changes that would be comparable to other municipalities of our size. Councilmember Keith Prather was appointed chair of the Compensation Committee and Councilmembers David Mullis, Jr. and William Malcom were also asked to be on this committee. The proposed changes will need to be ready to present to the Council in August.
10. **Adjourn:** Councilmember David Mullis, Jr. made a motion to adjourn the meeting, Councilmember Kelsey Malcom seconded, all approved and the meeting was adjourned at 7:26 pm.
