## Good Hope City Council Minutes July 8, 2024

1. **Call to order:** Mayor Randy Garrett called the meeting to order at 6:32 pm and led the invocation, Councilmember Keith Prather led the pledge.
2. **Roll Call:** Performed by City Clerk Missy Daigle, All Councilmembers were present.
3. **Approval of agenda:** There were no amendments to be added, Councilmember William Malcom made a motion to accept the agenda as presented, Councilmember David Mullis, Jr. seconded, and all approved.
