Good Hope City Council Minutes July 8, 2024

- 1. Call to order: Mayor Randy Garrett called the meeting to order at 6:32 pm and led the invocation, Councilmember Keith Prather led the pledge.
- 2. Roll Call: Performed by City Clerk Missy Daigle, All Councilmembers were present.
- 3. Approval of agenda: There were no amendments to be added, Councilmember William Malcom made a motion to accept the agenda as presented, Councilmember David Mullis, Jr. seconded, and all approved.
- 4. Approval of previous meeting's minutes: Councilmember Keith Prather made a motion to accept June Council minutes and Councilmember John Robison, Jr. seconded, all approved, motion passed and minutes were recorded.
- 5. Public Forum: No visitors were present.
- 6. Committee Reports/Updates:
